Subject: Request Authorization for staff to attend the 2023 CALAFCO Staff Workshop

Background

Historically, the Executive Officer and the one LAFCO Staff member attend each year's CALAFCO Staff Workshop to keep up to speed and informed on the latest LAFCO processing changes and best management practices. LAFCO continues to contract with the Kings County Community Development Agency (CDA) for staff to serve as LAFCO staff. This year the Executive Officer is also requesting that in addition to himself and the one staff member to attend the workshop he would like legal counsel to be afforded the opportunity to attend as well so that he can be informed on the latest LAFCO processes and practices.

The LAFCO FY Budget for 2022/2023 planned for the attendance of LAFCO staff members to attend this year's CALAFCO Staff Workshop. This year's Staff Workshop runs from April 26 thru 28 and will be in Murphys, CA at the Ironstone Vineyard and hosted by Calaveras LAFCo. Registration is estimated to be \$360 per person for LAFCO members and an added Mobile Workshop for an additional \$60. The following expenses are estimated for this workshop for three staff members to attend:

Registration: \$1,260 for three attendees

Hotel: \$1,926 three rooms for three nights (\$189 per night plus tax)

Travel: \$180 rental car and gas

Meals: \$645 perdiem allowance adjusted for included meals for three attendees

Est. Total: \$4,011

The LAFCO FY Budget for 2022/2023 currently has \$5,070 left remaining in the In Service and the Training and Travel related accounts. This CALAFCO Staff Workshop is the only planned training remaining in this fiscal year, so there is sufficient funding available in the current budget and there should be an end of the year balance of approximately \$1,059.
