**CALL TO ORDER:** A special meeting of the Local Agency Formation Commission of Kings County was called to order by Chairman, Joe Neves, at 1:14 p.m., on April 19, 2023, in the Hanford Civic Auditorium, located at 400 N. Douty Street, in Hanford, California.

**UNSCHEDULED APPEARANCES**: Andre Musgrave, representing Toor Farms, spoke in

opposition of Sphere of Influence/Annexation No. 23-01. He requested the proposal be delayed in order to allow property owners could conduct

independent investigations.

Bitta Toor, representing Toor Farms, spoke in opposition of Sphere of Influence/Annexation No. 23-01. He requested his statements be considered and the proposal be denied. His additional comments are included in the public hearing

comments.

Chairman Neves acknowledged the passing of Commissioner Dan Chin on March 29, 2023. A moment of silence was observed in remembrance of Commissioner Chin, who served nearly 9 years with LAFCO.

#### **APPROVAL OF MINUTES:**

A motion was made and seconded (Verboon/Devine) to approve the minutes of the March 22, 2023 meeting. Motion carried unanimously with three in favor and two absent.

#### **OLD BUSINESS:**

A. None

#### **NEW BUSINESS**

**A. Sphere of Influence/Annexation No. 23-01 (Tulare Lake Drainage District)** – Mr. Kinney provided the Executive Officer Report. He discussed the requirements for approval of the application. He stated the Tulare Lake Drainage District submitted an application (LAFCO Case No. 23-01) to annex APN's 026-200-001, 003, 004, 005, 006, 011, 012 and APN's 026-210-021, 039, 040, 041, 042, 043 into the Tulare Lake Drainage District. The subject parcels are 1284.86 acres and are contiguous to the District boundary. The project site is located on the southeast corner of Lansing Avenue and the 18th Avenue intersection. A sphere of influence amendment must first be adopted by the Commission before the proposed annexation may be considered. This SOI amendment proposes to include the land needed for the annexation mentioned above. Mr. Kinney stated according to the findings for the proposed annexation, he recommended the Commission hold the public hearing and thereafter approve Sphere of Influence/Annexation No. 23-01 by adopting Resolution 23-01.

Chairman Neves queried if there were any questions or comments by Commissioners. There were no questions or comments.

Chairman Neves opened the public hearing for comment.

Bitta Toor provided additional comments, requesting the Commission reconsider Sphere of Influence/Annexation No. 23-01. He stated he had not heard of the item until he received notice of the meeting.

Parm Singh, F.T. Farms LLC, stated he did not receive notice of proposed Sphere of Influence/Annexation No. 23-01. Mr. Kinney clarified that notices were sent to property owners within 300 feet of subject property and next adjacent parcels as required by code. He stated notice was also published in the local newspaper to advise of the public hearing. He also stated the notice was posted on the Kings LAFCO website along with the agenda packet.

Viola Compton stated she did not receive notice until end of the week prior.

Dustin Fuller, Tulare Lake Drainage District, spoke in regard to Mr. Toor's comments. He explained previous contacts between Tulare Lake Drainage District and Mr. Toor.

An unnamed individual inquired if the meeting was to authorize dumping water in the area shown on the map that was included with the notice. Mr. Kinney explained the meeting and proposal were a different matter. Chairman Neves requested Dustin Fuller explain the tail water process and the intention of the proposal. Commissioner Verboon, Mr. Fuller, and Chairman Neves continued discussion of the specifics of the water irrigation process associated with the proposal.

Parm Singh presented follow-up comments in regard to Tulare Lake Drainage District having storage capacity due to growers in the locale of the annexation being landlocked. He mentioned concerns regarding fees for assessment and easement request. Mr. Fuller explained the easement is through private property and not with the Tulare Lake Drainage District. Mr. Fuller further explained the fee amounts.

Bitta Toor presented follow-up comments explaining how assistance from Tulare Lake Drainage District would help. He stated those requesting the annexation are Tulare Lake Drainage District board members and are acting in self interest.

Commissioner Verboon inquired about LAFCO's jurisdiction in facilitating mediation between the conflicting parties, to which Mr. Kinney explained LAFCO does not have such authority. Mr. Kinney explained LAFCO's position and authority in the matter. Mr. Kinney also advised of contacting Kings County Public Works for additional options and information.

Chairman Neves requested Mr. Kinney to restate the findings and discuss any that may have weaknesses. Mr. Kinney restated the findings and stated he was not seeing any weaknesses. Chairman Neves explained LAFCO's authority in regard to Tulare Lake Drainage District and the Commissions responsibility as it pertains to the proposal. Bitta Toor requested the Commission postpone the decision until Toor Farms could meet with Tulare Lake Drainage District to resolve their concerns.

Chairman Neves, seeing there were no further comments, proceeded to close the public hearing.

A motion was made and seconded (Verboon/Devine) to continue the Sphere of Influence/Annexation No. 23-01 and Resolution 23-01 to the next scheduled meeting of May 24, 2023. Motion carried unanimously with three in favor and two absent.

**B. LAFCO Preliminary Budget FY 2023-2024** – Mr. Kinney explained the Fiscal Year 2023-24 LAFCO Budget. He stated the total requested budget is \$78,638 and represents an increase of \$2,436 (3.2%) from the Fiscal Year 2022-23 LAFCO Budget. He continued with specific descriptions of the increase and expenses proposed. He stated the cost allocated to each municipal jurisdiction was included in the agenda packet for the meeting. Mr. Kinney recommended the Commission open the public hearing to receive public comment and then continue the public hearing to the May 24, 2023 LAFCO meeting.

Chairman Neves queried if there were any questions or comments for the Commissioners. There were no questions or comments.

Chairman Neves opened the public hearing. He asked Mr. Kinney if there were any written comments received, to which Mr. Kinney replied no. Chairman Neves, seeing no one wishing to present public comment, continued the public hearing to the May 24, 2023 LAFCO meeting.

#### STAFF REPORT May 24, 2023

EXECUTIVE OFFICER'S REPORT

Tulare Lake Drainage District – Sphere of Influence Amendment/Annexation No. 23-01

#### I. INTRODUCTION:

The Tulare Lake Drainage District has submitted an application (LAFCO Case No. 23-01) to annex APN's 026-200-001, 003, 004, 005, 006, 011, 012 and APN's 026-210-021, 039, 040, 041, 042, 043 into the Tulare Lake Drainage District. The subject parcels are 1284.86 acres and are contiguous to the District boundary. The project site is located on the southeast corner of Lansing Avenue and the 18<sup>th</sup> Avenue intersection.

A sphere of influence amendment must first be adopted by the Commission before the proposed annexation may be considered. This SOI amendment proposes to include the land needed for the annexation mentioned above.

#### II. SPHERE OF INFLUENCE ANALYSIS AND FINDINGS:

A sphere of influence is defined by Government Code Section 56076 as "...a plan for the probable physical boundaries and service area of a local agency, as determined by the Commission". Section 56425(e) requires the LAFCO Commission to consider:

- 1) The present and planned land uses in the area, including agricultural and open space lands;
- 2) The present and probable need for public facilities and services in the area;
- 3) The present capacity of public facilities and adequacy of public services which the agency provides or is authorized to provide; and
- 4) The existence of any social or economic communities of interest in the area if the commission determines that they are relevant to the agency.
- 5) For an update of a sphere of influence of a city or special district that provides public facilities or services related to sewers, municipal and industrial water, or structural fire protection, that occurs pursuant to subdivision (g) on or after July 1, 2012, the present and probable need for those public facilities and services of any disadvantaged unincorporated communities within the existing sphere of influence.

#### A. Present and Planned Uses in the Area

The land proposed for annexation in LAFCO Case No. 23-01 has been utilized for agricultural operations. The proposed annexation site contains the following general plan and zoning designations.

Kings County Zoning: General Agriculture (AG-40)

The current and proposed use of this land is for the cultivation and farming of agricultural crops. The planned annexation would allow for agricultural drainage water disposal services to be provided to the lands proposed within the annexation.

#### B. Present and Probable Need for Public Facilities and Services

The current cultivated fields could benefit from the use of the agricultural drainage water disposal service and a connection to these services can efficiently be added as shown in the attached (Exhibit "A") Municipal Service Review.

#### C. Present Capacity of Public Facilities and Adequacy of Public Services

Tulare Lake Drainage District (TLDD or District) provides agricultural drainage disposal services to lands within its boundary. The District does not provide any other service. The proposed annexation territory is adjacent to the current District boundary. Land use within the proposed annexation territory is consistent with lands currently in the District's boundary. In addition, the Municipal Service Review (MSR) (see attached Exhibit "A") provides analysis on the present and planned capacity of facilities and the adequacy of services.

#### D. Evidence of Any Social or Economic Communities of Interest

This is not applicable to the proposed sphere of influence amendment. A social or economic community of interest does not exist in the area.

#### E. Disadvantaged Unincorporated Communities

No Disadvantaged Unincorporated Communities exist within the current Primary Sphere of Influence. No additional DUC's have been identified in the vicinity. The project sites are comprised of agricultural land.

California Government Code Section 56426.6(a) states that the Commission shall not approve a change to the sphere of influence of a local government agency of territory that is subject to a contract entered into pursuant to the California Land Conservation Act of 1965 (Chapter 7 (commencing with Section 51200) of Part 1 of Division 1) if that local government agency provides, or would provide, facilities or services related to sewers, nonagricultural water, or streets and roads to the territory, unless these facilities or services benefit land uses that are allowed under the contract and the landowner consents to the change to the sphere of influence. Since the Tulare Lake Drainage District does not provide facilities or services related to sewers, nonagricultural water, nor streets and roads, this project is consistent with California Government Code Section 56426.6(a).

#### III. ANNEXATION ANALYSIS AND FINDINGS:

#### I. BRIEF OVERVIEW OF PROPOSAL:

The proposal is to annex one area which totals 1284.86 acres to the Tulare Lake Drainage District. The area includes thirteen parcels located on the southeast corner of Lansing Avenue and the 18<sup>th</sup> Avenue intersection. This territory is adjacent to the Tulare Lake Drainage District and if approved by Kings LAFCo today would be within the District's Primary Sphere of Influence as adopted by LAFCO and effective May 24, 2023. See Exhibit "A" for a location map of the project site. This proposed reorganization is not considered inhabited since fewer than 12 registered voters reside within the boundaries of the proposed annexation. 100% of the property owners have signed a document consenting to this area of land being annexed into the Tulare Lake Drainage District. The Commission may consider the proposal without notice, hearing, or election pursuant to Government Code Section 56662. The proposal is currently under a Williamson Act Contract.

#### II. EXECUTIVE OFFICERS RECOMMENDATION

The Executive Officer recommends the LAFCO Commission consider the project and adopt LAFCO Resolution No. 23-01 for approval of LAFCO Case No. 23-01 "Tulare Lake Drainage District 2022 Annexation". The application does represent 100 percent consent of land owners.

#### III. ANALYSIS OF PROPOSAL:

#### A. Discussion of Proposal

A Tulare Lake Drainage District application for annexation of territory was received on December 19, 2022. The application was certified complete on January 31, 2023. The purpose of the action is to annex one area containing thirteen parcels totaling 1284.86 acres into the Tulare Lake Drainage District. All of the properties are privately owned and the district is the project proponent.

The area represents thirteen parcels located southeast of the corner of 18<sup>th</sup> Avenue and Lansing Avenue. Under the Kings County General Plan, the project area is designated as General Agriculture. The site is zoned AG-40.

2. Need for organized community services; the present cost and adequacy of governmental services and controls in the area; probable future needs for those services and controls; probable effect of the proposed incorporation, formation, annexation, or exclusion and of alternative courses of action on the cost and adequacy of services and controls in the area and adjacent areas.

The current land use surrounding the proposed annexation Area are primarily agricultural type uses. The Kings County General Plan designates the area as agricultural uses. The area is comprised of agricultural fields. The proposed development is to establish a tile drainage system on the approximately 1284.86 acres of agricultural land which would then drain into the existing agricultural drainage system which is run and operated by the Tulare Lake Drainage District. The Tulare Lake Drainage District is the most logical provider of this type of agricultural service within the Area, and annexation is required for the District to provide service. The Tulare Lake Drainage District will establish an appropriate rate for drainage service and connection fees and sufficient capacity has been identified to exist to serve the annexed territory.

3. The effect of the proposed action and of alternative actions, on adjacent areas, on mutual social and economic interests, and on the local governmental structure of the county.

There is no anticipated effect of the proposed action on adjacent areas, on mutual social and economic interests, and on the local governmental structure of the County.

4. The conformity of both the proposal and its anticipated effects with both the adopted commission policies on providing planned, orderly, efficient patterns of urban development, and the policies and priorities set forth in Section 56377.

The proposed annexation is a planned and orderly extension of the Tulare Lake Drainage District. The 2035 Kings County General Plan designates this area for agricultural uses. Therefore, the impact of this proposal upon patterns of development will occur as outlined in the County's General Plan. Since the District currently borders the project area along the southern border, this territory would keep extension of services in line with the orderly development of the District. This

proposal is in keeping with the intent of LAFCO as detailed in Section 56301, and is reflected in the Policies and Procedures manual for LAFCO of Kings County whereby it encourages the orderly formation of local governmental agencies.

5. The effect of the proposal on maintaining the physical and economic integrity of agricultural lands, as defined by Section 56016.

The annexation territory is planned for Agricultural uses under the County's 2035 General Plan. The annexation of this property into the Tulare Lake Drainage District will allow these properties to obtain agricultural drainage services which will benefit the physical and economic integrity of these agricultural lands.

The proposal is currently under a Williamson Act Contract.

6. The definiteness and certainty of the boundaries of the territory, the nonconformance of proposed boundaries with lines of assessment or ownership, the creation of islands or corridors of unincorporated territory, and other similar matters affecting the proposed boundaries.

The boundaries are definite and certain (See Exhibit "A" of the Resolution). No islands or substantially surrounded areas will be created as a result of this annexation.

7. A regional transportation plan adopted pursuant to Section 65080.

The 2022 Kings County Regional Transportation Plan was adopted on September 14, 2022 pursuant to Section 65080 of the California Government Code.

8. Consistency with city or county general and specific plans.

The annexation is consistent with the 2035 Kings County General Plan

Current Zoning: General Agriculture (AG-40)

County General Plan Designation: General Agriculture.

9. The sphere of influence of any local agency which may be applicable to the proposal being reviewed.

This territory is adjacent to the Tulare Lake Drainage District and if approved by Kings LAFCo today would be within the District's Primary Sphere of Influence as adopted by LAFCO and effective May 24, 2023.

10. The comments of any affected local agency or other public agency.

No written comments have been received by the Executive Officer as of May 17, 2023.

11. The ability of the newly formed or receiving entity to provide the services which are the subject of the application to the area, including the sufficiency of revenues for those services following the proposed boundary change.

The District indicates that services for agricultural drainage can be provided to the annexation territory.

12. Timely availability of water supplies adequate for projected needs as specified in Section 65352.5.

The District only provides for agricultural drainage services therefore Section 65352.5 does not pertain to this annexation.

13. The extent to which the proposal will affect a city or cities and the county in achieving their respective fair shares of the regional housing needs as determined by the appropriate council of governments consistent with Article 10.6 (commencing with Section 65580) of Chapter 3 of Division 1 of Title 7.

The subject territory is planned for Agricultural uses and proposes to use the site for cultivation of agricultural crops. Since this property is zoned Agricultural, the County of Kings has never considered it to be used for housing purposes and was not relied upon when planning for the 2014 Kings County Regional Housing Needs Allocation Plan, nor was it included in the 2016 Housing Element update.

#### 14. Any information or comments from the landowner or owners.

Notices for todays meeting to hold a public hearing was mailed out to inform existing residents and land owners in the annexation area. All of the landowners of the area proposed for annexation have signed a consent form for the proposed annexation to the Tulare Lake Drainage District. No additional information or comments have been received by property owners or residents in regards to this proposal.

15. Any information relating to existing land use designations.

No other information is applicable.

16. Extent to which the proposal will promote environmental justice.

The proposed annexation will not result in inferior services being provided to areas of low income residents. The annexation does include project specific information regarding future development of the land to be used for cultivation of agricultural crops. In addition, the proposal will not locate undesirable land uses within the proximity of low income residents.

#### IV. ENVIRONMENTAL ASSESSMENT:

Inclusion of the proposed territory described as LAFCO Case No. 23-01 – Tulare Lake Drainage District 2022 Annexation for inclusion into the District's Primary Sphere of Influence was reviewed by the District and determined that the inclusion of these lands into the District's Primary Sphere of Influence is categorically exempt from CEQA under Section 15319(a) which states that annexations to a special district of areas containing existing public or private structures developed to the density allowed by the current zoning or pre-zoning of either the gaining or losing governmental agency whichever is more restrictive, provided, however, that the extension of utility services to the existing facilities would have a capacity to serve only the existing facilities. This area has historically been used for the growing of agricultural crops and the proposed land use designation and zoning for the sites are Agricultural, which will only allow agricultural uses. This proposed Sphere of Influence Amendment and Annexation will not change the existing use of the land and will not result in any change to the environment. LAFCO, as a Responsible Agency, may rely upon Tulare Lake Drainage District's categorical exemption determination for this action.

#### IV. RECOMMENDATIONS:

The Executive Officer recommends that:

- A. Recommendations concerning the Sphere of Influence Amendment:
  - 1. The Commission make the following determinations:
    - a) It is a Responsible Agency under the California Environmental Quality Act Guidelines, Section 15096, and finds that:
      - 1) The areas of land designated as Agricultural which are included in this Sphere of Influence Amendment are Categorically Exempt from CEQA under Section 15319; and
    - b) The Sphere of Influence Amendment is determined exempt from the *California Environmental Quality Act (CEQA)* under the General Rule Exemption, Public Resources Code Section 15061(b)(3) of the CEQA Guidelines.
    - c) The required considerations for Sphere of Influence amendments mandated by Government Code Section 56425(e) have been met as set forth in the attached resolution.
  - 2. The Commission approve the sphere of influence amendment for the Tulare Lake Drainage District by adopting LAFCO Resolution 23-01.

#### B. Recommendations concerning the Annexation:

- 1. That the Commission make the following determinations:
  - a) It is a Responsible Agency under the California Environmental Quality Act Guidelines, Section 15096.
  - b) The annexation is being taken pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000.
  - c) The distinctive short form designation of the annexation is "Tulare Lake Drainage District 2022 Annexation".
  - d) The District requested annexation of one unincorporated area and all the property owners have given consent to the annexation.
  - e) The proposed annexation conforms to the newly adopted sphere of influence for the Tulare Lake Drainage District.
  - f) The subject territory is not considered inhabited.
  - g) All of the factors required by Government Code Section 56668 have been considered by the Commission before rendering a decision.
  - h) The reorganization is necessary to provide agricultural drainage services.
  - i) The regular county assessment roll will be utilized for this annexation.
  - j) The affected territory will not be taxed for existing general bonded indebtedness.
- 2. Find that the Commission has reviewed the Class 19 Categorical Exclusion for the annexation by the Tulare Lake Drainage District and has relied on the determination therein that this project will not have a significant effect on the environment.

#### **MUNICIPAL SERVICES REVIEW**

#### **Tulare Lake Drainage District**

#### 2022 Annexation

Tulare Lake Drainage District (TLDD or District) provides agricultural drainage disposal services to lands within its boundary. The District does not provide any other service. The proposed annexation territory is adjacent to the current District boundary. Land use within the proposed annexation territory is consistent with lands currently in the District's boundary.

The following information was prepared in accordance with California Government Code Section 56430, to assist Kings County LAFCO with developing its Municipal Service Review and updating spheres of influence of the Tulare Lake Drainage District.

California Government Code Section 56430

(https://california.public.law/codes/ca gov't code section 56430)

- a) In order to prepare and to update spheres of influence in accordance with Section 56425, the commission shall conduct a service review of the municipal services provided in the county or other appropriate area designated by the commission. The commission shall include in the area designated for service review the county, the region, the subregion, or any other geographic area as is appropriate for an analysis of the service or services to be reviewed, and shall prepare a written statement of its determinations with respect to each of the following: Section 5643 of the California Government Code requires a service review of the municipal services provided in the area. The government code requires a written determination of each of the following:
  - 1. Growth and population projections for the affected area
    - All lands within the proposed annexation area are irrigated agricultural lands, owned by the same party. Population nor land use within the proposed annexation area is expected to change in the foreseeable future. No urban expansion into the proposed annexation area is currently proposed and is not expected. The provision of drainage services to these lands by the District will have no effect on population/growth within the annexation area. Annexation of the proposed territory by TLDD will not impact growth or populations.
  - 2. The location and characteristics of any disadvantaged unincorporated communities within or contiguous to the sphere of influence.
    - There are no disadvantaged communities within or adjacent to the proposed annexation territory. The community nearest to the proposed annexation is the unincorporated community of Stratford (approximately 2 miles West of the proposed annexation).

3. Present and planned capacity of public facilities, adequacy of public services, and infrastructure needs or deficiencies including needs or deficiencies related to sewers, municipal and industrial water, and structural fire protection in any disadvantaged, unincorporated communities within or contiguous to the sphere of influence.

The District's drainage disposal system has adequate capacity to accommodate drainage flows from the proposed annexation territory. The annexation does not affect any other public facilities, services or infrastructure. Additionally, the District does not provide any public services outside of agricultural drainage disposal.

4. Financial ability of agencies to provide services.

No modification to District facilities are required and no changes to District operations will be required to accommodate new drainage flows from the annexation territory. The District is financially stable and is capable of providing agricultural drain water disposal services to the lands with the proposed annexation territory. The District will recover costs for drainage services provided to the annexation territory through annual assessments.

5. Status of, and opportunities for, shared facilities.

District facilities convey and dispose of agricultural drain water which is high in salt concentration and other constitutes. District facilities are not suitable for any other purpose than conveying agricultural drainage water.

6. Accountability for community service needs, including governmental structure and operational efficiencies.

The District provides a highly specialized and unique service. Tulare Lake Drainage District operates under waste discharge requirements issued by the State Water Resources Control board (WDR No. R5-2015-0134 and 93-136) and works closely with environmental and regulatory agencies to ensure compliance with applicable state and federal laws.

7. Any other matter related to effective or efficient service delivery, as required by commission policy.

There are no other matters relative to effective or efficient service delivery.

b) In conducting a service review, the commission shall comprehensively review all of the agencies that provide the identified service or services within the designated geographic area. The commission may assess various alternatives for improving efficiency and affordability of infrastructure and service delivery within and contiguous to the sphere of influence, including, but not limited to, the consolidation of governmental agencies.

There are no other entities that provide agricultural drainage disposal services in the area.

c) In conducting a service review, the commission may include a review of whether the agencies under review, including any public water system as defined in Section 116275, are in compliance with the California Safe Drinking Water Act (Chapter 4 (commencing with Section 116270) of Part 12 of Division 104 of the Health and Safety Code). A public water system may satisfy any request for information as to compliance with that act by submission of the consumer confidence or water quality report prepared by the public water system as provided by Section 116470 of the Health and Safety Code.

Tulare Lake Drainage District does not operate a public water system.

d) The commission may request information, as part of a service review under this section, from identified public or private entities that provide wholesale or retail supply of drinking water, including mutual water companies formed pursuant to Part 7 (commencing with Section 14300) of Division 3 of Title 1 of the Corporations Code, and private utilities, as defined in Section 1502 of the Public Utilities Code.

Tulare Lake Drainage District does not provide wholesale or retail supplies of drinking water.

e) The commission shall conduct a service review before, or in conjunction with, but no later than the time it is considering an action to establish a sphere of influence in accordance with Section 56425 or 56426.5 or to update a sphere of influence pursuant to Section 56425.


- 4) <u>Evidence of Any Social or Economic Communities of Interest:</u> This is not applicable to the proposed sphere of influence amendment. A social or economic community of interest does not exist in the area.
- <u>Disadvantaged Unincorporated Communities:</u> No Disadvantaged Unincorporated Communities exist within the current Primary Sphere of Influence. No additional DUC's have been identified in the vicinity. The project sites are comprised of agricultural land.

SUBJECT: 2023-2024 Proposed Budget

#### I. INTRODUCTION:

The Executive Officer's proposed Fiscal Year 2023-2024 LAFCO Budget is provided for the Commission's consideration and adoption. This proposed budget was first presented to the Commission as a Preliminary Budget review on March 22, 2023, and presented as the Proposed Budget with the first public hearing on April 19, 2023. This proposed budget of \$78,638 is an increase of \$2,436 more than last year's request, a 3.20% increase. The requested amount covers LAFCO's general activities as required by Assembly Bill 2838, the Cortese – Knox – Hertzberg Act, and continued involvement with CALAFCO to keep current on legislative and procedural changes. Revenues are projected at \$41,319. This amount includes the estimated LAFCO Application Fees of \$4,000 and City shares for half of the remaining LAFCO budget. The County covers the remaining half of the LAFCO Budget share of \$37,319, which is an increase of \$1,218 from last FY.

#### II. LAFCO 2023-2024 FISCAL YEAR OBJECTIVES

The primary objectives for the 2023-2024 Fiscal Year Budget will center on continued training for LAFCO staff on operational procedures and processes, timely processing of reorganization and extension of service applications, processing of all spheres of influence amendments for the cities, communities, and special districts in Kings County, and preparing resources for the next required update. Staff will also review and assist Cities and Districts with the preparation of detailed MSRs for any Sphere of Influence Amendment application submitted to LAFCO to ensure compliance with Government Code Section 56430. As LAFCO staff is often relied upon by Cities to advise their prospective development applicants on annexation processes, staff needs to remain current on LAFCO processes, procedures, issues and implementation strategies. Continuing Legislative changes to LAFCO processes and procedures also necessitates staff's need for continual update through CALAFCO legislative review activities. LAFCO staff has remained actively involved with CALAFCO workshops and other training venues

to fulfill that need. The two annual CALAFCO training events are organized by LAFCO volunteers to keep all LAFCOs current on issues and implementation strategies.

#### III. RECOMMENDATION:

The Executive Officer recommends that the Commission continue the public hearing to receive public comment and testimony on the proposed LAFCO Budget and consider adoption.
