### A. LAFCO Case No. 06-06, Hanford Reorganization No. 131

Mr. Gatzka stated they received an e-mail from CALAFCO stating that AB2223 was signed by the Governor which extends the Island Annexation provisions to January 1, 2014. He also noted that AB2701 was signed which relates specifically to the Los Osos Community Services District.
